Sub: Maintenance and Operation of NMG coaches

All crew must strictly adhere to the following instructions:

1. While working NMG rakes, whenever negotiating 1 in 8.5 turnouts, the maximum permissible speed of the train shall not exceed 10 kmph.

Note: As a precautionary measure, this speed restriction shall apply on all loop lines of the division.

2. While negotiating second and subsequent loop lines with BLC and loaded EUR rakes, the maximum permissible speed shall not exceed 10 kmph.

All crew are directed to follow these instructions strictly, and all CLIs shall counsel the crew accordingly.

Sub: Movement of container Flat Wagon (BLC) and loaded EUR rakes on second and subsequent loops.

Ref. Railway Board's letter of even no. dated 18.03.2025.

Vide referred letter, the restrictions imposed as per earlier letter of even no. dated 09.02.2016 for movement of container flat wagons (BLC) and loaded EUR rakes on second and subsequent loops was provisionally withdrawn.

In partial modification to the instruction contained in referred letter, it has been decided from safety consideration that the movements of these two types of Rolling stocks are to be restricted upto 10 kmph on second and subsequent loops, till such time, negotiability trials are conducted with Instrumented Wheel Sets by RDSO.

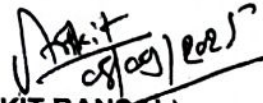
Railway Board vide letter mentioned under reference (2), had issued guidelines regarding maintenance and operation of NMG coaches, based on RPSO's trial report.

"Limiting the speed of NMG train to 10 kmph while moving over 1 in 8.5 turnouts. Any local speed restriction shall prevail over this speed. This is approved as a temporary measure only for a period of 6 months."

Now Railway Board vide letter mentioned under reference (1) has extended the trial for further period of 6 months.

In view of the above, Divisions are advised to counsel all the running staff on the above subject.

Sub : Speed restriction for NMG type rakes over 1 in 8.5 turnouts.

**Ref : Railway Board's letter no. 2020/M(C)/650/2pt. dated 03.06.2025
and 04.12.2024**

Railway Board, vide letter no. 2020/M(C)/650/2pt. dated 04.12.2024, had issued instructions to restrict the speed of NMG type rakes to 10 kmph while moving over 1 in 8.5 turnouts, for a period of six months, on a trial basis. Board, vide letter dt 03.06.2025, has extended the trial for a further period of six months. A copy of the letter is enclosed for reference.

Zonal Railways are advised to counsel all Loco Pilots and Assistant Loco Pilots to strictly adhere to the prescribed speed limit of 10 kmph for NMG type rakes, while moving over 1 in 8.5 turnouts, till any relaxation is issued.
